

Contact was made by officers with LONGO. The accused exploded over the phone, yelling that he had been denied what was owed to him. Officers spoke with the accused at length, advised him there were grounds for his arrest and suggested LONGO surrender himself to police. At 6:10 pm Francesco LONGO attended Windsor Police Headquarters where officers confirmed the accused's identity by Ontario driver's licence and photo ID, plus a digital file photo in police records. LONGO was placed under arrest for Mischief Over \$5000 contrary to section 430(1)(a) of the Criminal Code of Canada. LONGO was advised of Rights to Counsel and Caution, and escorted to the Detention Unit where he was viewed by the intake sergeant. LONGO was later released on an Undertaking with conditions. Francesco has no current criminal charges. He has one conviction for assault.
