ORDER

THIS MOTION made by the Applicant, Francesco Giovanni Longo, for an Order pursuant to Rule 2.01 and Rule 3.02 of the Criminal Proceeding Rules, was heard on [DATE] at Windsor, Ontario.

ON READING the Notice of Application, the Affidavit of Francesco Giovanni Longo sworn January ___, 2026, and the Motion for Judgment Without Hearing, and on hearing the submissions (if any):

THIS COURT ORDERS THAT:

- TIME ABRIDGMENT

Pursuant to Rule 3.02, time for service is abridged to permit filing on January 7, 2026.

- HEARING DISPENSED

Pursuant to Rule 2.01, the requirement for a hearing is dispensed with in the interests of justice.

- INTERIM FUNDING

Legal Aid Ontario shall pay Francesco Giovanni Longo interim damages estimated at **between \$1,500,000 and \$3,915,000** within 24 hours of this Order to fund independent legal counsel.

- INDEPENDENT COUNSEL

Francesco Giovanni Longo is authorized to retain **out-of-province independent counsel of his choosing**. Legal Aid Ontario shall not assign or control counsel selection.

- DECLARATION - NO FORMAL DISMISSAL

IT IS DECLARED that the charges against Francesco Giovanni Longo under case numbers 21-845, 21-38605, 21-38609, 94545, and 211549 were not formally dismissed by written court order and no CPIC clearance has been provided.

- PROHIBITION ON RE-FILING & NEW CHARGE CREATION

Legal Aid Ontario, the Crown Attorney's Office, and Windsor Police Service are PROHIBITED from:

- Re-filing charges under the above case numbers without leave of this Court
- Creating NEW fabricated charges using fingerprints, mugshots, or 13 missing photographs without leave of this Court

- CPIC CLEARANCE

Windsor Police Service shall provide written confirmation within 7 days that Francesco Giovanni Longo has **ZERO** active, inactive, or purged records in CPIC.

- RCMP CRIMINAL RECORDS EXPLANATION

Windsor Police Service and RCMP shall provide written explanation within 14 days as to why RCMP created TWO criminal records for Francesco Giovanni Longo marked "FBI" and "CONFIDENTIAL" when he is an innocent man with zero charges.

- DAMAGES RESERVED

Final damages to be determined at trial or further hearing.

- COSTS

Costs of this application are reserved.
