AFFIDAVIT OF FRANCESCO GIOVANNI LONGO

FORM 4 - AFFIDAVIT

I, FRANCESCO GIOVANNI LONGO, of the City of Windsor, in the Province of Ontario,
MAKE OATH AND SAY:

• IDENTITY

I am 52 years old and the Applicant in this matter. I have personal knowledge of the facts set out in this Affidavit.

• ARREST - MAY 6, 2021

On **May 6, 2021**, I **voluntarily attended** Windsor Police Service. I was detained and handcuffed. **I do not know which officer arrested me or placed me in handcuffs.** I was detained for approximately **45 minutes or more** and released the same day **in the evening.**

At the time, I was not charged with any offence **on the paperwork**. However, police **told me verbally** I was being charged with **Mischief Over \$5,000**. I only realized later that **no such charge was written on any documentation**.

- RETROACTIVE CHARGE - MAY 22, 2021 (16 DAYS AFTER ARREST)

On **May 22, 2021**—sixteen (16) days after my arrest—**Charge #211549** was created **retroactively** and appears in police documentation dated May 22, 2021.

This charge was not filed in court until 2022—approximately **14 months later**.

For 14 months (until 2022), they had time to fabricate additional evidence under this charge number. However, they **prosecuted me under Information #21-845**, NOT Charge #211549.

This retroactive charge resulted in a **criminal record** and **denial of my U.S. Green Card application**.

- CASE NUMBER CONFUSION

I have reviewed police reports and court documents. There are **multiple conflicting case numbers, occurrence numbers, charge numbers, and information numbers** across different documents:

- **21-845** (Information Number) — They **prosecuted me under this number**
- **21-38605** (Occurrence Number in police reports) — But listed as a **CHARGE** in my disclosure forms — **this is the discrepancy**
- **21-38609** (Occurrence Number — appears in some documents but NOT in Windsor Police reports) — **I don't know if this number exists or was fabricated**
- **94545** (Case Number)
- **211549** (Charge Number — created May 22, 2021; filed 14 months later in 2022)

This is NOT my job as an innocent Canadian citizen to investigate these discrepancies. I need legal counsel to resolve this properly. **I respectfully ask the Court to resolve this confusion.**

- **NO FORMAL DISMISSAL OF CHARGES**

In September or October 2025, I received an email from the Crown Attorney's Office stating they have "**no active files**" (plural) for me.

However:

- There is **NO written court order** dismissing these charges or any of these numbers
- There is **NO CPIC clearance letter**
- The Crown referred to "**files**" (plural), suggesting multiple cases exist

Crown email says "no active files" (plural). Does this mean there are INACTIVE files? Why are there ANY files at all when I have zero criminal record?

I remain at risk of these charges being re-filed at any time.

- RCMP CRIMINAL RECORDS & "CONFIDENTIAL" DESIGNATION

RCMP created TWO criminal records for me stating "**FBI**" on the documents.

My cover statement says "**CONFIDENTIAL**".

Why is an innocent man with zero charges marked "CONFIDENTIAL"? What is confidential about Francesco Giovanni Longo when he has no criminal record?

- LEGAL AID ONTARIO DENIAL

In **June or July 2025**, after terminating my private counsel, I applied to Legal Aid Ontario (LAO) for funding.

LAO has denied me funding since my application.

My LAO Client File Number is: **CLT 132-5791**

I have **11 audio recordings** of LAO denying me funding. We also have these recordings in **text format**.

I am indigent. I cannot afford counsel. Without LAO funding, I cannot defend myself if charges are re-filed.

- ONGOING FABRICATION OF EVIDENCE

I believe there is ongoing fabrication of evidence in my case:

A. 13 MISSING PHOTOGRAPHS

Disclosure documents state "**Photographic: 13**", indicating 13 photographs were taken.

ALL 13 photographs have been erased.

These photographs were removed from disclosure **after I made an emergency preservation request and after I fired my lawyer.**

I do not know what these photographs depicted.

I am TERRIFIED they are planning to create a charge using those photographs. They have my **fingerprints and mugshot** when there should be **NOTHING of that sort**. They already tried this once. **Who knows how many times they've attempted this?**

B. THREE CONTRADICTORY ARREST NARRATIVES

Police reports contain **three completely different arrest stories**:

- **Narrative #1:** Officer arrested me "**out in the field**"
- **Narrative #2:** Officer arrested me "**inside the police station**"
- **Narrative #3:** I "**voluntarily walked into the police department**"

This proves fabrication. All three cannot be true. These are false narratives they have already created.

C. RESTITUTION FRAUD

In some documents, **Hayley Zvaniga** is listed as "**Victim #1**" in a Mischief case.

No dollar amount is specified for restitution.

I do not understand:

- Why restitution exists in a Mischief case at all
- Who is convicted
- Who will receive the money

I am terrified. I do not trust Windsor Police, Crown, or Court officials whatsoever. **This is ongoing fabrication, not just one case.** You can see the fabricated accounts and false narratives they have already created.

- EVIDENCE IN SUPPORT OF THIS APPLICATION

I have the following evidence to support this Application:

- **11 audio recordings** of Legal Aid Ontario denying me funding (also available in text format)
 - **2 disclosure forms** showing contradictory arrest narratives
 - **Police reports:**
 - Property Report (May 6, 2021) listing **NO CHARGES**
 - MCMS 38 (May 22, 2021) showing **Charge #211549 created 16 days after arrest**
 - Multiple documents showing conflicting case numbers
 - **Disclosure documents** stating "**Photographic: 13**" (all erased after emergency preservation request and after I fired my lawyer)
 - **Crown email** (Sept/Oct 2025) stating "**no active files**" (plural)
 - **RCMP criminal records** (TWO records stating "FBI"; cover statement marked "CONFIDENTIAL")
 - **Exhibit A:** LAO STUDY.pdf (55% systemic denial rate; obstruction patterns)
 - **Exhibit B:** LAO_LEGAL_DUTY_ANALYSIS.md (LAO duty continues until formal dismissal)
 - **Exhibit C:** LAO_LSO_STUDY_SUMMARY_JAN7_2026.md (1 in 10⁸¹ probability; LSO capacity proof)

- INTERIM FUNDING REQUEST

I require **interim funding estimated at between \$1,500,000 and \$3,915,000** to:

- Retain **independent out-of-province counsel of my choosing** (NOT LAO counsel)
 - Cover travel and preparation costs for counsel from outside Ontario
 - Obtain written court orders dismissing all charges and all case numbers
 - Obtain CPIC clearance confirming **ZERO** records
 - Defend against potential re-filing of charges **AND creation of NEW fabricated charges**

- ONGOING LEGAL DANGER

Without independent counsel, I remain in ongoing legal danger:

- Charges dismissed without written court order
- No CPIC clearance
- Risk of **re-filing existing charges** (1 year for summary offences / indefinite for indictable offences)
- Risk of **creation of NEW fabricated charges** using evidence they have already collected (fingerprints, mugshots, 13 missing photographs)
- Cannot defend myself if charges re-filed or newly created
- LAO denial = Charter breach (sections 7, 10(b))

- URGENCY

This matter is urgent:

- I face **imminent eviction** risk
- I have **no ability to defend** myself if charges are re-filed or newly created
- **Every day without counsel = irreparable harm**
- There is **no prejudice to LAO** (LAO has my complete file)
- My vehicle is not currently working; I do not have money for transportation
- Thank God I defended myself, because they would have gotten away with murder
- I need money to hire a legal attorney who can do this correctly and properly

I respectfully request judgment on the papers pursuant to Rule 2.01 in the interests of justice.
